Barry explained that the season is proposed to have an extra week in 2023 which will enable washed out matches to be played. Barry also stated that the DDGA will be more forceful on scheduling dates for finals and other matches should the need arise in the future. Mark Ryle likes the Junior concept that was introduced but saw impediments to the competition when junior golfers have to give shots away to more senior players. The meeting suggested that the committee look at the championships and what could be done to encourage attendance, especially from clubs that were due to host the following year.

AGM Date: Mark Ryle asked if it may be possible to have the AGM on the same day as the DDGA Championships which are always held at the same club each year.

Unfortunately, we had a Junior withdraw last minute and we were not able to find a replacement, this meant we were one player short in this division. The 3 Juniors that participated played well and we most likely would have won the shield had we been able to field a complete side.

Congratulations to our players in the Colts, Open & Seniors divisions who were successful in winning the shields for 2022. This is a great achievement and shows that we have great depth in the golfing talent throughout the DDGA. Thank you to Jim Miller and Norm Mitchell for their help selecting the team.

Thanks to the team at Toowoomba Golf Club and also Jim Miller and Colin Hoey for their efforts hosting and co-ordinating a very successful day. The feedback was very positive from the other participating districts, well done to all.

Inter Association: This year will see our team off to Far North Qld to compete. Our team for this event will be Anthony Timms, Patrick Callaghan, Chris Webster & Jack Oster. Good Luck gents, enjoy the experience.

DDGA Pennants: The 2022 open season saw the same format as in previous years and again was very competitive and the standard of golf was high. The Handicap and Senior divisions were again hugely successful and very competitive, we will be calling for nominations in these divisions in the coming months. Congratulations to all pennant winners in 2022 and thank you to all who participated and our clubs for presenting the courses in great golfing conditions under trying circumstances due to the weather.

Zone Championships, Zone Events & Sand Greens: The number of participants at these events has been slightly down on previous years, with several clubs not having any representatives at these events. This is a little disappointing as every club has the chance to host the Zone events on a rotation basis. Thank you to all the travelling members that attended these championships. A big thank you to the staff and volunteers at the host venues this year for your professionalism in the way you presented the courses and for your hospitality on the day of the events.

Open Carnivals: This year we decided that the points system would not be run in conjunction with these events. It will be interesting to see if this affects the participation levels at the carnivals. For the events that have been held thus far, the number of visiting players is still high.

General: Unfortunately, this year has seen the closure of the Wallangarra GC bringing the number of Golf Clubs in the DDGA down to 19. This has meant the committee is analysing whether a change to the clubs in each of our zones needs to take place. No formal decision has been made on this thus far.

I would like to take the opportunity to remind each club that we have money set aside in our budget to support and grow all levels of golf throughout the association. If any committee has a programme or idea that they would like funding for, please present it to us for consideration.

On behalf of the management committee, thank you to City Golf Club for allowing us to use your boardroom for our Bi-monthly committee meetings. It is greatly appreciated.

I have mentioned at a member of Executive Meetings that the information/communication from Golf Queensland has lessened markedly from what it was prior to coming under the umbrella of Golf Australia. I am not suggesting that the administration of our game is superior or inferior to what it was but the governing bod's communication with Districts is now somewhat scant. I have endeavoured to list some of the more noteworthy "news".

Golf Qld AGM:

- At the last AGM held in May 2022 the Golf Queensland Year was changed from a calendar year to a period of 12 months commencing on 01 July and ending on 30 June. As a result, the next Golf Qld AGM will take place in November 2022.

New Golf Queensland Chair:

In line with the process outlined in the Golf Qld Constitution, Peter Reeves has been appointed Chair of Golf Qld following the resignation of David Brett.

General:

- Outback Qld Masters very successful – has become a popular event.
- GQ Year End Date – to be June 30 to align with Golf Australia.
- 2023 Affiliation fees: to be \$37.42 including gst. Increase of 3.55%
- Paid by all clubs to Golf Qld in 2023 – not inclusive of any Golf Australia or District component.
- Remote clubs still pay 70%.
- Golf Australia membership up by 6%
- Golf Australia Strategy Document is on the website – in partnership with PGA and WPGA.
- AGM was held Friday May 27.
- 3 Vacancies and 3 nominees – Judy Logan, Michelle Stanley and David Brett duly elected.
- Sale of Golf Qld office at Bowen Hills completed in April; proceeds of such sale together with the sale of GQ Training Centre proceeds have been invested in a Golf Qld Investment Fund – 4.7 M. To provide long term capital growth as well as a stable annual income stream.
- New Golf Australia Office is on Level 1, Schneider Road, Eagle Farm.

I would personally like to thank Barry for his great contribution and leadership to the DDGA over many years, especially during his tenure as President. Best wishes to you and your family Barry and I'll see you on the course.

Given this may be my final year as Delegate, I must say I have enjoyed my time in this role and thank you all for your great support and involvement in Downs golf.

Congratulations to all pennant winners for 2022.

This season was one of ups and downs. Firstly, it saw a change to the handicap format with 3 divisions of Handicap pennants, each with their own final. This came about due to an interest shown by a couple of clubs who had not played pennants for a few seasons, and both City and Toowoomba expressing to us during the 2021 season that they would like a format available to them to introduce their 18-hole Juniors to club pennants. To accommodate this, we asked both City and Toowoomba submit a team in this division thinking it would be a way for the clubs to introduce their 18-hole Juniors to pennants. With this in mind, we asked Warwick & Gatton to compete in this division also, with the hope that soon we can run this division to incorporate at least 2 Juniors as a compulsory part of each team. However, with clubs still struggling for numbers it is likely this will not be the case in the coming season.

Towards the end of the season the whole of the DDGA experienced a weather event which meant that nearly all the golf courses throughout the DDGA were deemed unplayable by their match committees. These circumstances effected both the final round and the finals weekend, neither of which we had solutions written into our pennant rules. It was decided by the pennant committee to leave it up to the individual clubs to determine whether the final round could be played, and it was also decided that the finals were to be set on a date that suited both participating clubs. A few weeks passed and at our June committee meeting it was decided that all finals were to be completed no later than the 3rd of July, which was achieved. A review took place after the completion of the season and there have been some alterations made to the rules for the 2023 season. We have also looked at the schedule around the pennant season and made some alterations to the timing of the season to allow for the possibility of postponing or cancelling a round or the final weekend.

I would like to thank Jim Miller and Shane Smith and for their help with the organisation and co-ordination of the 2022 pennant season.

Thank you to our clubs for presenting the venues the best they could in such trying conditions. Finally, I would like to thank players and club officials for their involvement in the 2022 season. This concludes the Pennant Report 2022.

Notes to and forming part of the financial statements For the year ended 31 August 2022

Note 1 – Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting obligations of the Associations Incorporation Act 1981 and the association's rules. The Committee has determined that the association is not a reporting entity.

The statements are prepared on a cash basis. They are based on historic costs and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of these financial statements:

Income Tax

As the association is a not-for-profit institution in terms of subsection 50-5 of the Income Tax Assessment Act 1997, as amended, it is exempt from paying income tax.

Property, Plant & Equipment (PPE)

Property, plant and equipment are carried at cost less, where applicable, any accumulated depreciation.

Impairment of assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

Employee Provisions

The association does not employ any staff and all workers are unpaid volunteers. Accordingly no provision is made for employee benefits.

Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of six months or less.

Revenue and Other Income

Revenue is measured at the fair value of the compensation received or receivable after taking into account any trade discounts allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised upon receipt.

Grant and donation income is recognised when the association obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive or retain the contribution, recognition of the grant as revenue is deferred until those conditions are satisfied.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the the amount of GST incurred is not recoverable from the Tax Office.

In these circumstances the GST is recognised as part of the cost of acquisition of the asset or part of an item of expense. Receivables and payables in the assets and liabilities statement are recorded inclusive of GST.
